Your Honor:

1. I would like to put in a request to be granted new counsel. First of all, I need to address an issue that needs to be handled ASAP. I reviewed the motion hearing on June 26th, 2024 when you ordered a competency exam to be completed. I request that the mental health examination be postponed until I have an opportunity to discuss this with newly appointed counsel. As of this date July 26th, 2024, I have not been advised by my attorney that the examination was needed, I only found out about it on July 4th by reading it in the Ashland Source. In addition, I was informed by your office that the examination would be administered by the same Doctor who did the NGRI report. My attorney called me after the hearing on July 9th, 2024 and only advised me that the trial had been postponed until October. I am receiving more information from a newspaper report and your office than I do from my current counsel Don Wick. I also found out from watching the hearing that my attorney is only planning on issuing possibly two or three subpoenas, of which I have no idea who he's planning on issuing subpoenas to because we have not discussed that. There is information that is crucial to my defense, from my perspective, that he has not been willing to obtain.

I was admitted to Med Central hospital on July 1st and released on Monday July 8th, 2024 due to an infection from an ulcer on my right heel that is healing very slowly. I was supposed to have a conversation with my attorney on Monday July 8th, at 11 a.m., however that was postponed until I was released. On Tuesday morning July 9th I replied to a text message from him asking me if I was released yet, I replied 4 minutes later asking him to give me a new date and time that we could talk. As of this date, July 26th I have not heard back from him. There is a serious communication problem between us and I should be provided proper counsel that has my best interest at heart. He has stated for me to call him if I have any questions but I feel he should be contacting me to discuss putting my defense together.
